Rental Fee, Concession Stand	
Daily usage	\$25
Deposit	\$75
Concession stand usage is for the purpose of raising funds for non-profit organizations, youth or adult athletic groups or a community function or party. Examples: 4H, Scouts, Youth Sports, Adult Leagues, Good Thunder Day Celebration, reunions and the like.
